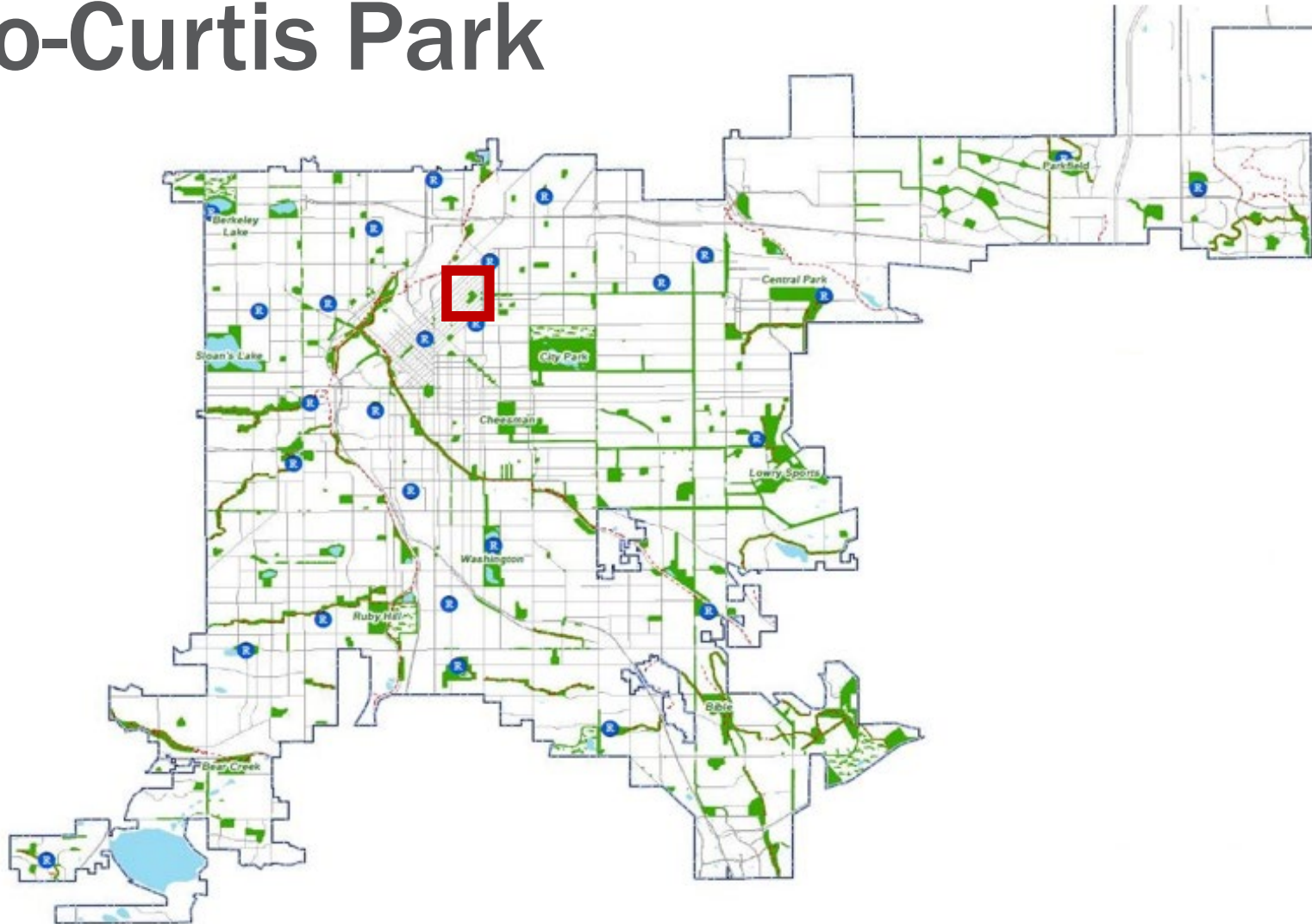

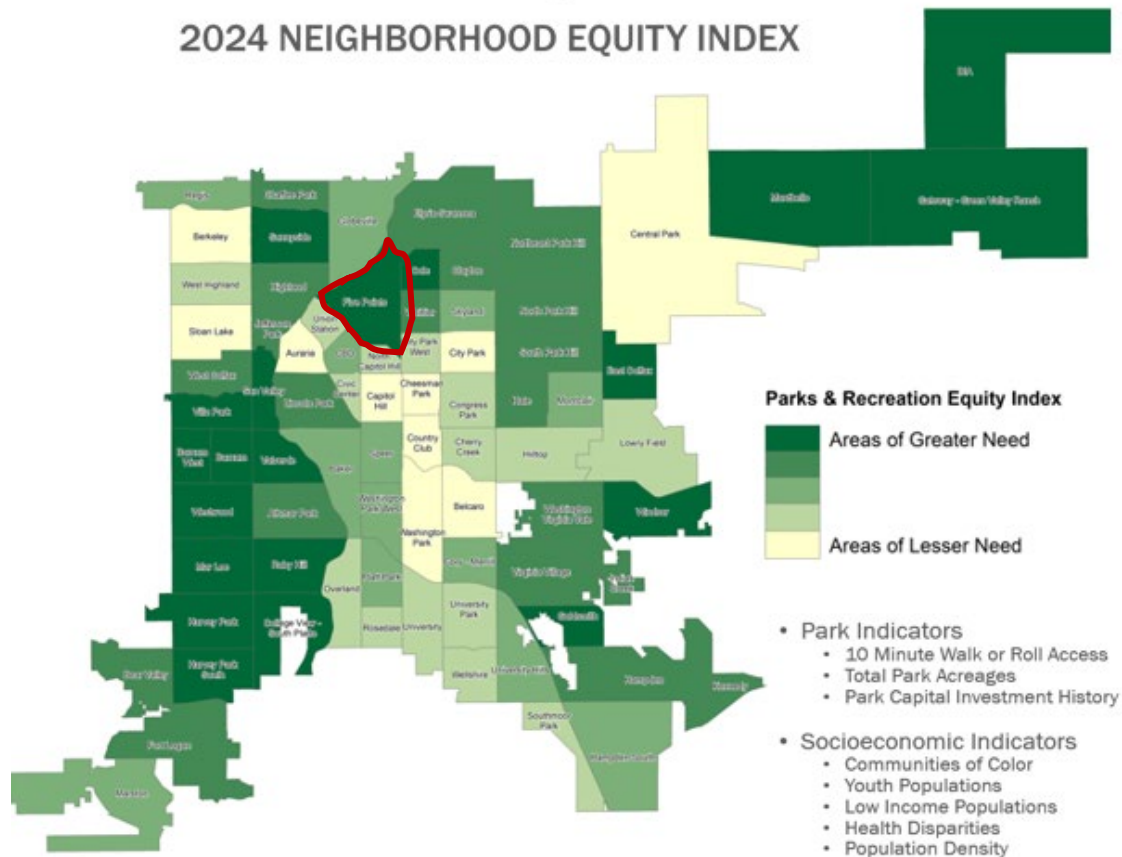

EQUITY AND ACCESSIBILITY



- Mestizo Curtis Park is part of the Five Points Neighborhood and rated as an “Area of Greater Need”
- Accessibility integrated into the design
 - Pool Chair Lifts
 - ADA Compliant Site and Bathhouse
 - Zero Depth and Ramp Entry

DESIGN AND COMMUNITY ENGAGEMENT

- Project Background

- Replace entire pool system originally built in the 50s
- \$14.5M Project Budget
 - Rise Bond = \$6,000,000
 - Legacy Funds = \$5,000,000
 - CIP Funds = \$3,500,000

- Project Details

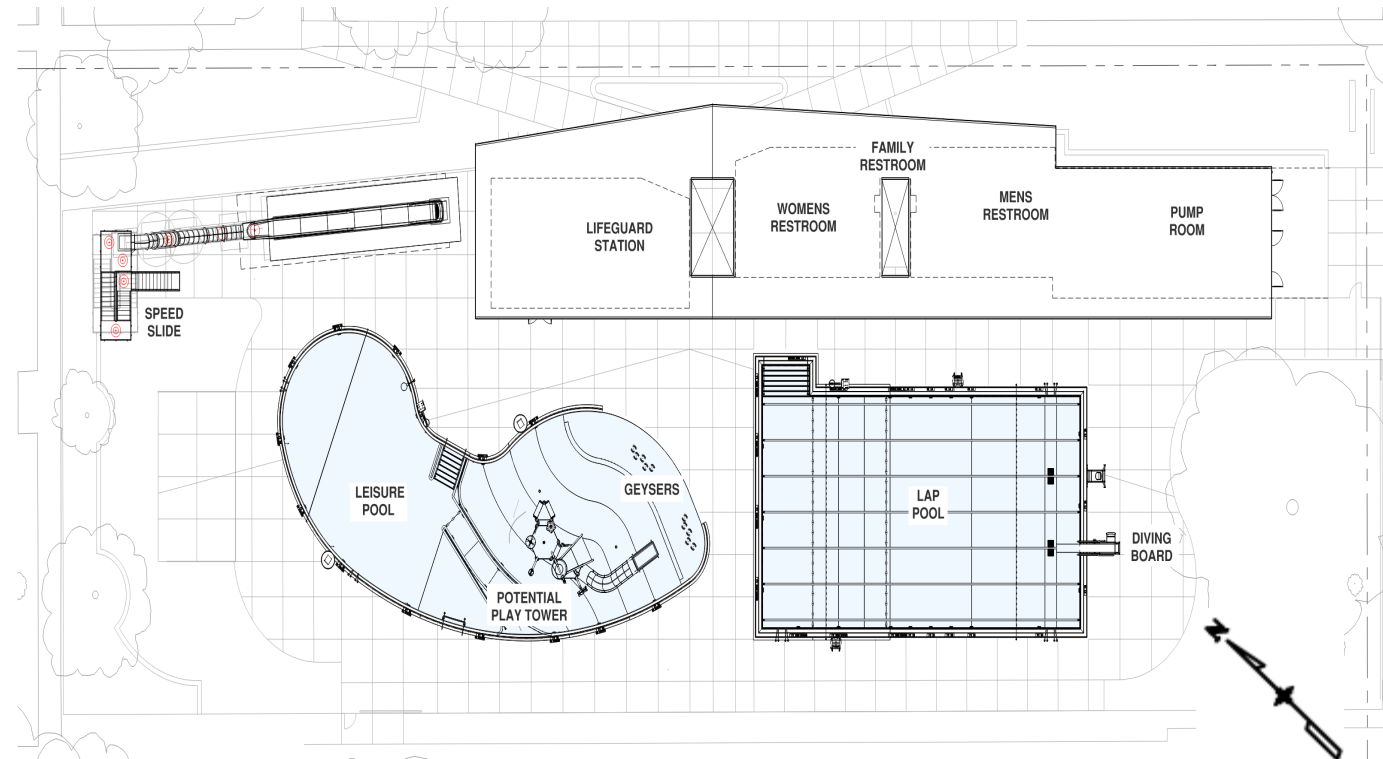
- 5,493 SF Bathhouse
- 3,768 SF Water Surface Water
- 17'6" FT at tallest roof point

- Aquatic Amenities

- 6 lane 25-yard lap pool with 12' deep end
- Leisure pool with open water and zero depth entry
- Slide & Aquatic play features for all ages
- Diving Board

- Aquatic Programming

- Swimming lessons
- Youth swim team
- Lifeguard training
- Aqua aerobics
- Lap swimming

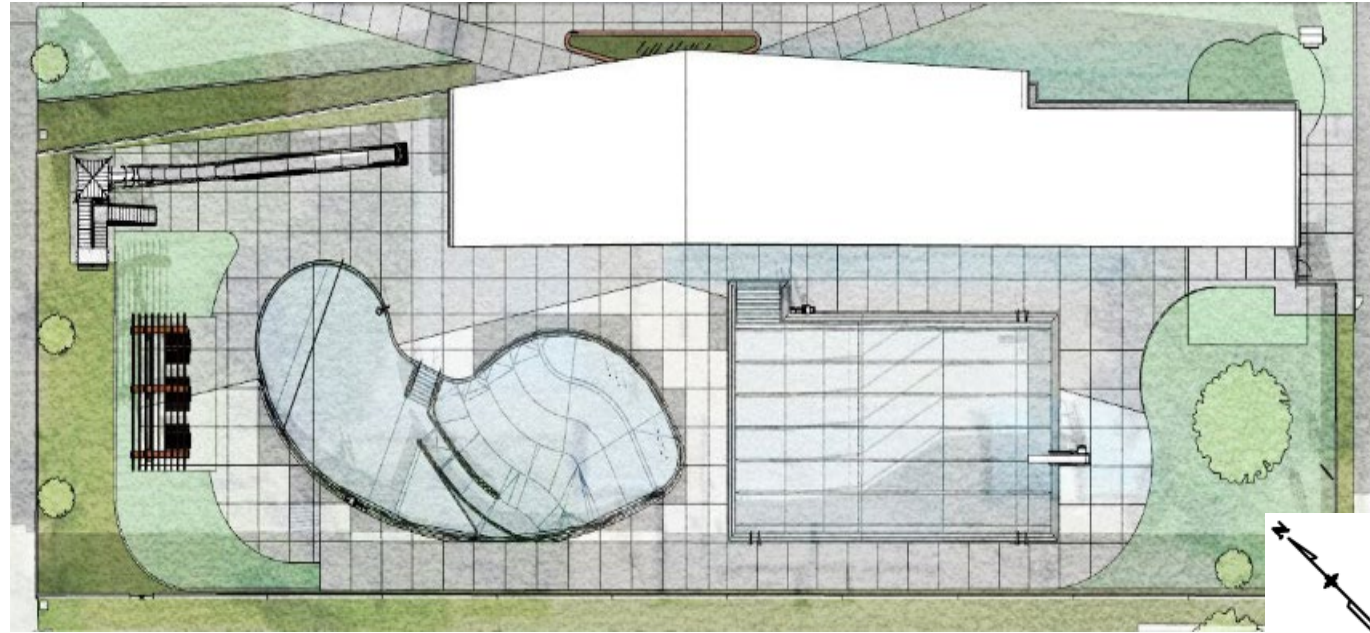

PARK BUILDING PLAN COUNCIL ACTION TIMELINE

- April 25, 2025 – Notification to RNOs
- May 1, 2025 – Presentation at Curtis Park Neighbors
- May 6, 2025 – LUTI Committee
- May 13, 2025 – Mayor-Council
- May 19, 2025 – First Reading
- June 2, 2025 – Public Hearing and Second Reading



CODE OVERVIEW

• Summary of Applicable Ordinances

- Denver Zoning Code - Structures in zone district OS-A shall be determined by City Council per D.R.M.C., Chapter 39
- Buildings in city parks with footprints over 3,000 SF or over 35 FT in height must be approved as part of a Park Building Plan by City Council

Park Building Plan (PBP) Requirements

- Indicate adjacent existing structures and open spaces
- Locate proposed buildings (or additions) in excess of 3,000 SF or over 35 FT in height
- Identify maximum SF of building footprint (or addition)
- Identify maximum height of building (or addition)
- Provide notification to Registered Neighborhood Organizations (RNOs)
- City Council Public Hearing
