Arts & Venues Denver has a number of food and beverage revenue contracts in the arenas division facilities (Red Rocks and Denver Coliseum) and the Crossroads Theatre and that are expiring in the coming year. In order to align the contract termination dates in anticipation of a bid process to renew these contracts, several amendments are required to align the termination dates to a common date of October 30, 2012.

The following amendment will serve to accomplish this goal.

Arts & Venues Denver, formerly Theatres & Arenas, has an existing bid/agreement with Aramark Facility Services (AFS) for housekeeping services at Red Rocks Amphitheatre, the Denver Coliseum, and Boettcher Concert Hall. The existing agreement was executed through a bid document with the Department of Purchasing. This Amendatory Agreement amends the "Term" section to extend term of contract for an additional four (4) months with a contract ends date of 10/31/12. This Amendatory Agreement amends the "Payment" section to extend maximum payable amount from \$8,700,000.00 to \$9,000,000.00 to accommodate the extended term.
