**A BILL**

**For an ordinance making a rescission from and an appropriation in the Culture and Recreation Special Revenue Fund Series to make a cash transfer to the Parks Legacy Capital Improvement Funds.**

**WHEREAS**, in 2018, Denver voters approved Ballot Measure 2A, which increased the sales tax rate by 0.25 percentage points starting January 1, 2019, to be spent on various programs and projects that support Parks, Trails and Open Space: and

**WHEREAS**, the City and County of Denver has a signed Purchase and Sale Agreement from Evergreen-Green Valley Ranch & Telluride Land, L.L.C., for the acquisition of Outlook at GVR – PAD 9 acquisition, an approximately 3.1-acre parcel generally located at 17598 Green Valley Ranch Boulevard in Denver’s Green Valley Ranch neighborhood; and

**WHEREAS**, the remainder of the purchase price and the City’s due diligence and transactional costs will be funded by 38424 Gateway Area Fee-in-lieu Fund – Parks and Rec; and

**WHEREAS**, the City desires to transfer from the Parks Legacy SRF to Parks Legacy Improvement Projects Funds to maintain scope of work for current projects and not delay projects due to escalating costs;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Culture and Recreation Special Revenue Fund, Accounting No. 15000, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
