6 **For an ordinance relinquishing all easements reserved in Ordinance No. 60,**  
7 **Series of 1979, recorded with Denver Clerk & Recorder at Book 1854 and Page**  
8 **590; and, portions of easements reserved in Ordinance No. 618, Series of 2006**  
9 **recorded with the Denver Clerk & Recorder at Reception No. 2006155051, located**  
10 **near the intersection of West 19th Avenue and Clay Street.**

11 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has  
12 found and determined that the public use, convenience and necessity no longer requires the  
13 easements in the areas hereinafter described, and subject to approval by ordinance, has  
14 relinquished the same;

15 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

16 **Section 1.** That the action of the Executive Director of Public Works in relinquishing all  
17 easements reserved in Ordinance No. 60, Series of 1979, recorded with the Denver Clerk &  
18 Recorder at Book 1854 and Page 590, be and the same is hereby approved and that all easements  
19 reserved in Ordinance No. 60, Series of 1979, are hereby relinquished.

20 **Section 2.** That the action of the Executive Director of Public Works in relinquishing portions  
21 of the easements established in Ordinance No. 618, Series of 2006, recorded with the Denver Clerk  
22 and Recorder at Reception No. 2006155051, in the following area:

24 BEING PORTIONS OF NON-ECLUSIVE EASEMENTS RESERVED BY THE CITY & COUNTY  
25 OF DENVER IN THAT CERTAIN ORDINANCE No. 618, SERIES OF 2006, RECORDED  
26 SEPTEMBER 27, 2006 AT RECEPTION No. 2006155051, LYING WITHIN THE SOUTHEAST  
27 QUARTER (SE ¼) OF SECTION 32, TOWNSHIP 3 SOUTH, RANGE 68 WEST OF THE SIXTH  
28 PRINCIPAL MERIDIDIAN, CITY & COUNTY OF DENVER, STATE OF COLORADO, OVER THE  
29 FOLLOWING DESCRIBED AREAS:

30 THE EAST 34 FEET OF PARCEL 19 AS DESCRIBED IN SAID ORDINANCE (CLAY STREET).  
31 TOGETHER WITH THE NORTH 40 FEET OF PARCEL 20 AS DESCRIBED IN SAID ORDINANCE
