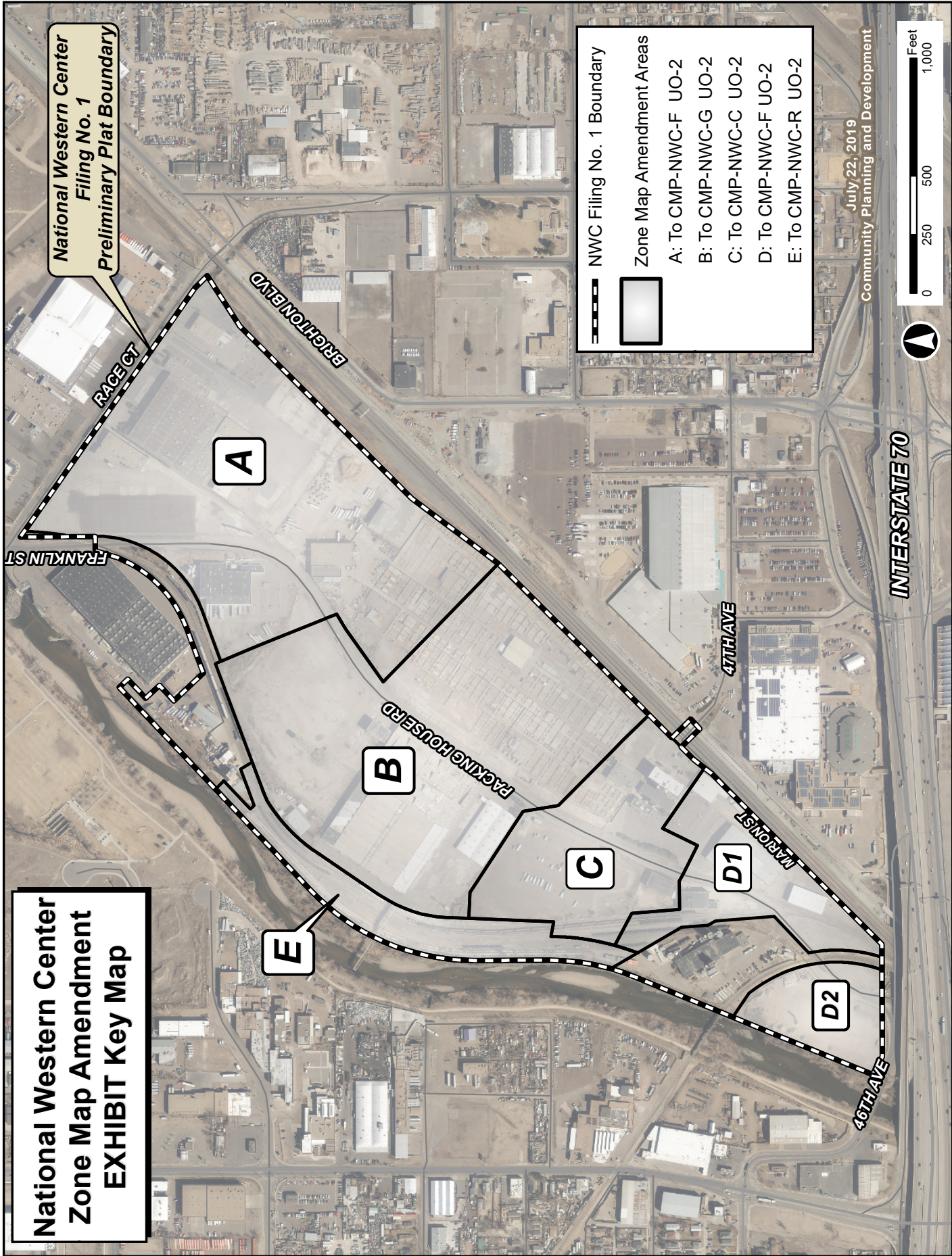
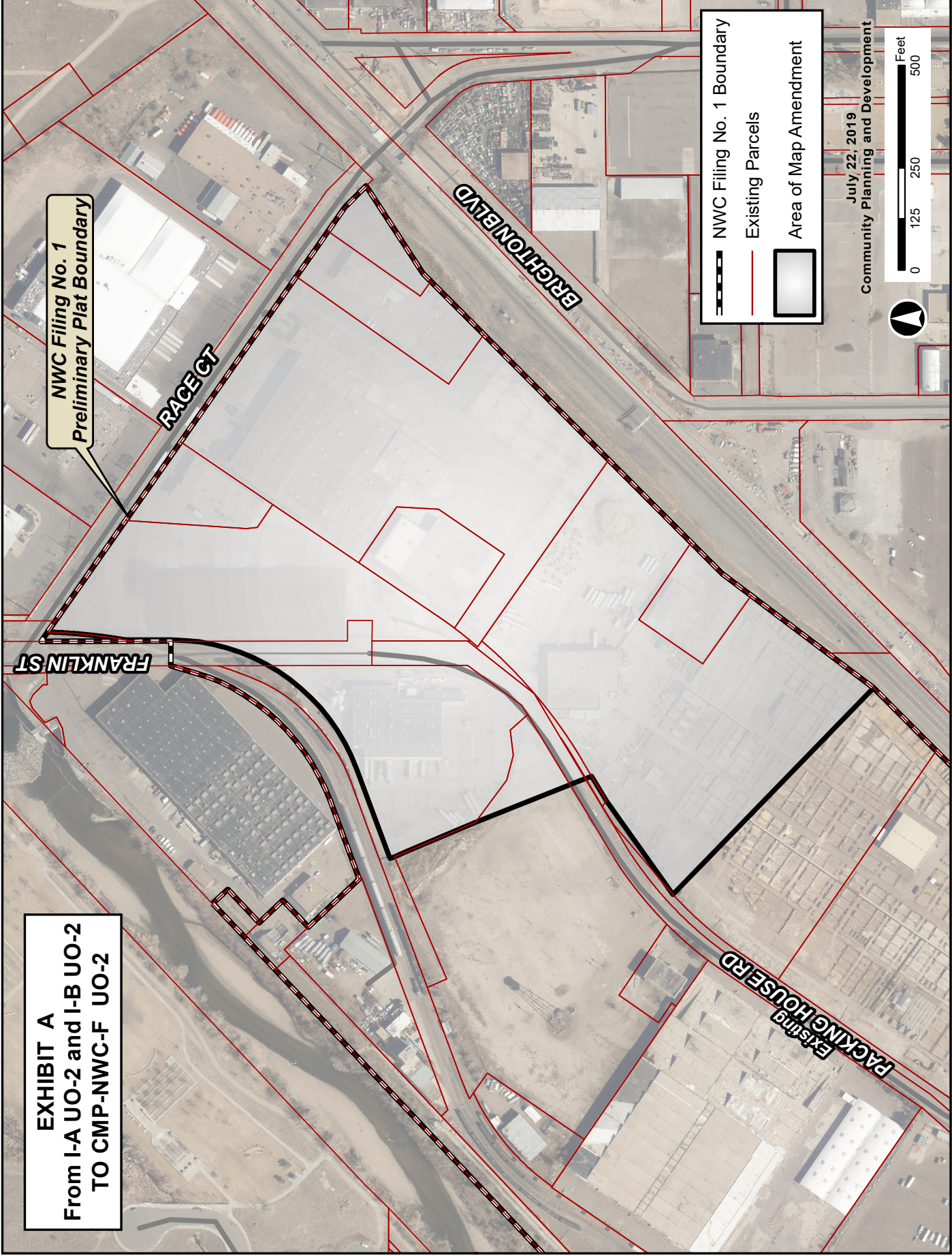

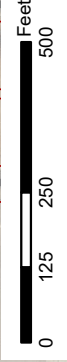

TO CMP-NWC-G UO-2**

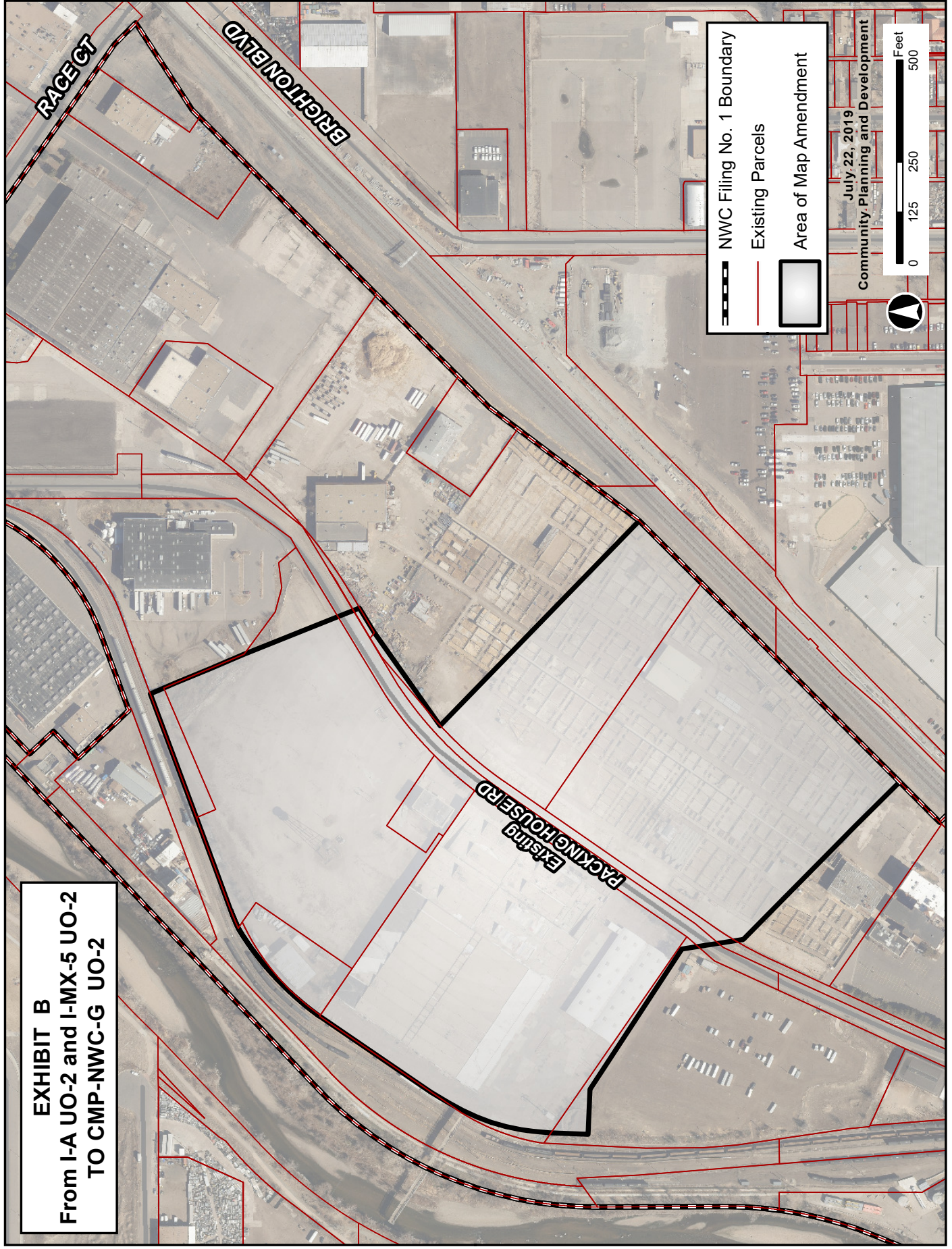
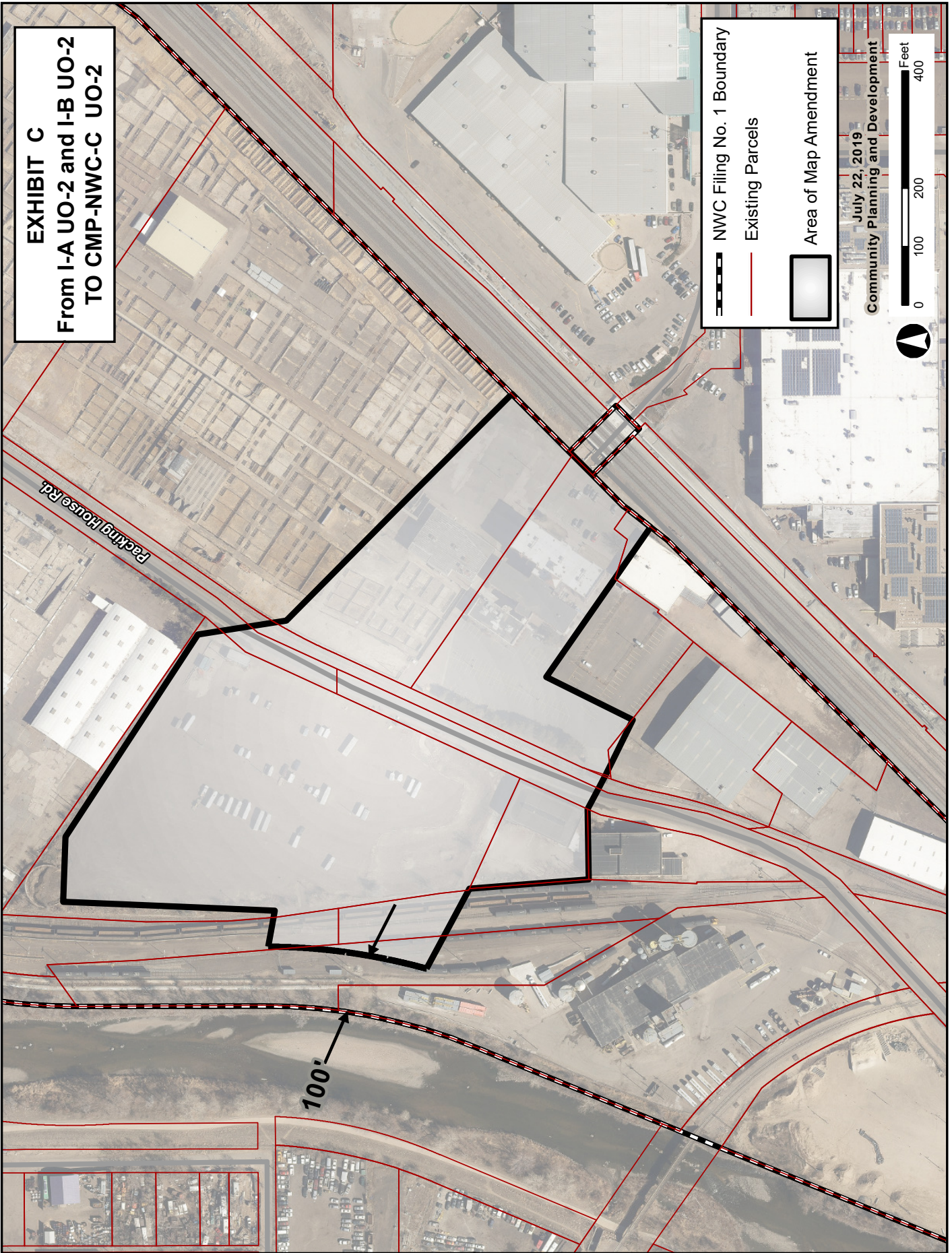

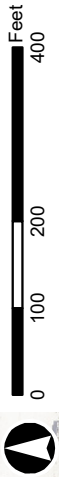

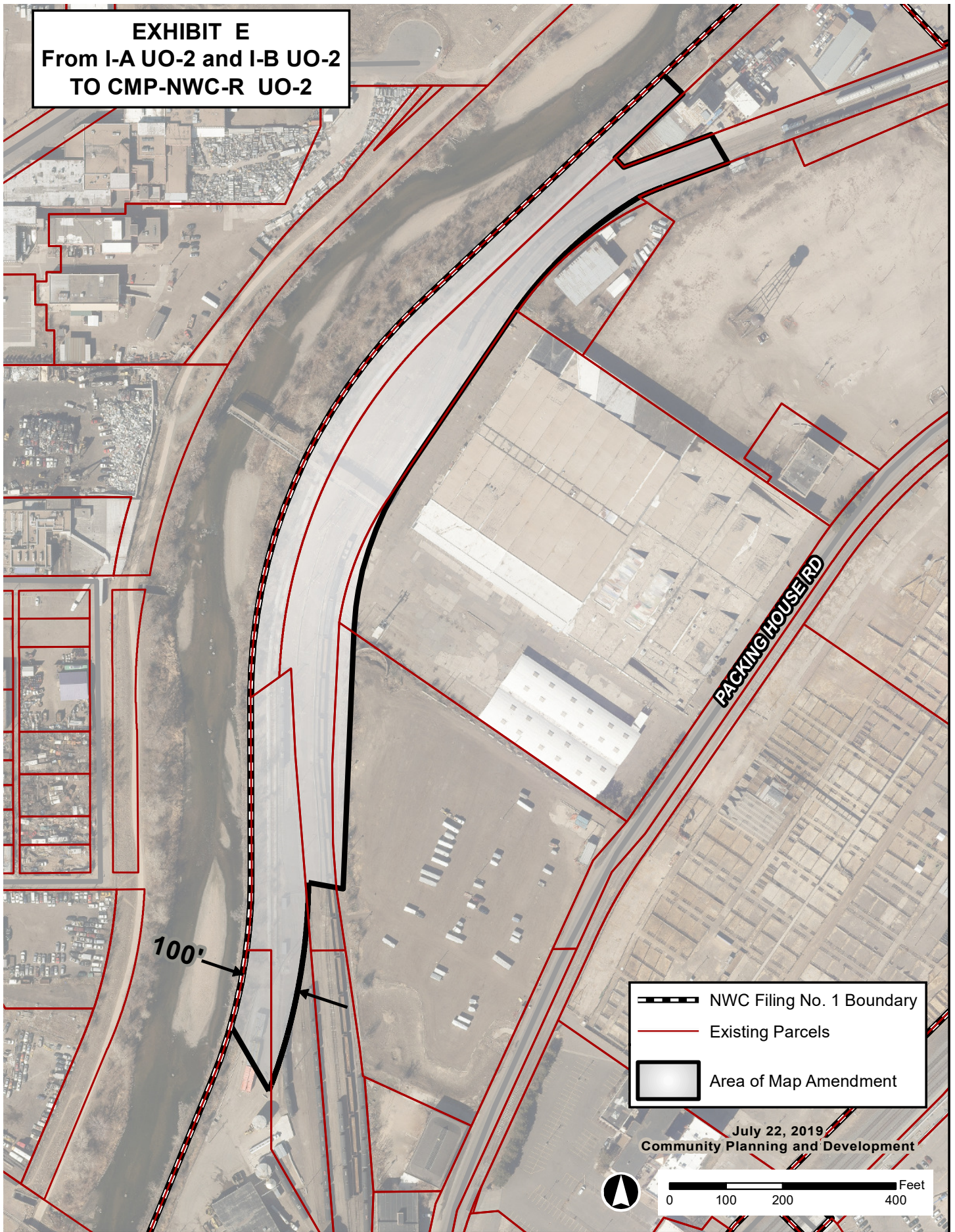
