This contractor will provide the City and County of Denver with corpse removal services, including the removal of dead human remains from scenes and hospitals to the Office of the Medical Examiner’s office. The contract is used every time the Denver Office of the Medical Examiner responds to a death scene. From those scenes SCI - Decedent Transport crews will pick up approximately 1500 deceased individuals annually, which can include suicides, homicides, decomposing, babies and infectious. All decedents are brought back to our office at 500 Quivas Street, Denver 80204.
