6. General description of proposed ordinance including contract scope of work if applicable:

In August, 2014 **CB14-0574** was passed. This bill amended DRMC 11-20, 11-21, 11-22, 20-18, 53-27(g), 53-28(a), 53-98(k), and 53-99(a) explicitly extending and increasing the preschool tax rate from .12% to .15%. The bill included asking Denver voters, in the November 2014 election, for authorization for the increase (which they did authorize). Unfortunately, Denver forgot to change two other sections of the ordinance 53-27(a) and 53-98(a) that references the new standard tax rate (should say 3.65% not 3.62%). Although this did not affect the legal imposition of the new increased tax rate, it does cause confusion and thus needs to be corrected as a housekeeping matter.
