On Monday, October 10, Council will sit as the Board of Equalization to hear any protests of assessment from the South Broadway (Arizona to Iowa) Local Maintenance District and the South Broadway (Arizona to Iowa) Local Improvement District.

On October 17, 2011, it is the intent of Council to convene as the Ex-officio Board of Directors of the Gateway Village General Improvement District to hold a public hearing on the District’s proposed 2012 Work Plan and Budget and to make appropriations and approve a mill levy for the Budget Year 2012.
