10 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

12 **Section 1.** That Article XII, "Denver Medical Marijuana Code," of Chapter 24, "Health and
13 Sanitation," of the Revised Municipal Code is amended by revising section 24-513 to read as
14 follows:

15 **Sec. 24-513. Term of licenses; renewals.**

17 (a) Effective March 1, 2014, any local license issued pursuant to this article XII shall be
18 valid for a period of ~~two (2) years~~ one (1) year from the date of issuance. Any renewal of
19 the license shall be governed by the standards and procedures set forth in the CMMC
20 and any regulations adopted pursuant thereto, subject to any additional restrictions on
21 renewal for certain classes of licenses in certain locations as provided in this article XII.

- 23 (b) Concerning existing two year licenses previously issued pursuant to this article XII, On
24 on or before the one-year anniversary date of any two year license issued pursuant to this
25 article XII, the licensee shall demonstrate to the satisfaction of the director that the
26 licensee has applied for and received a one-year renewal of the licensee's state license
27 from the state licensing authority and shall pay the annual licensing fee for the second
28 year of the local license as provided in section 32-93(3). Failure of the licensee to renew
29 and keep current the state license or to make timely payment of the local licensing fee
30 shall be grounds for immediate revocation of any license issued pursuant to this article
31 XII.

33 (c) Regardless of whether the license was previously issued for a one or two year period,
34 renewal of any license issued pursuant to this article XII shall be for a period not to
35 exceed one year.
