The City Council will hold a public hearing and have final consideration on the proposed Zoning Text Amendment at its regular meeting on June 16, 2014.

Proposed Amendment

Councilwoman Kniech propose a package of amendments designed to allow sale of certain types of fresh produce and/or cottage food sales from home.

History of the Bill

March 25 Council's Land Use, Transportation & Infrastructure Committee (LUTI) reviewed the proposal.
April 22 Planning Board reviewed the proposed amendment and recommended approval to City Council.
May 7 Planning Board held a public hearing on the proposal and recommended approval to City Council.
May 13 LUTI Committee approved filing the bill.
May 19 City Council ordered the bill published and set a public hearing date of June 16, 2014.
