### A. Auditor -

BR10-0345 - Amends Chapter 20, Section 20-76(e) of the Revised Municipal Code authorizing the Auditor to assess penalties against contractors paying workers less than prevailing wages.

### B. Cultural Affairs -

BR10-0346 - Contract approval between the City of Denver and Biennial of the Americas Corporation (BOAC).

### C. Denver International Airport -

BR10-0356 - Lease between DIA and Worldwide Flight Services, Inc.

#### D. Denver Public Library -

BR10-0347 - Contract with Brodart Co. and Midwest Tape in the amount of \$3,570,000.00 for vendor services for Denver Public Library.

## E. DIA -

BR10-0355 - Request for execution of a Eleventh Amendment to a Lease Agreement between US Government General Services Administration and the City and County of Denver.

BR10-0357 - Request for a contract execution for the Electronic Airport Layout Plan (eALP) to be conducted by Woolpert.

### F. Finance -

BR10-0340 - A bill for an ordinance to amend Chapter 32 to adjust occupational privilege tax registration fees.

BR10-0331 - A bill for an ordinance authorizing the issuance of City and County of Denver, Colorado, Tax-Exempt General Obligation Better Denver Bonds, Series 2010A, the City and County of Denver, Colorado, Taxable General Obligation Better Denver Bonds (Direct Pay Build America Bonds), Series 2010B, and the Tax-Exempt General Obligation Refunding Bonds, Series 2010C, for the purpose of financing and/or refinancing and defraying the cost of acquiring, constructing, installing and improving various civic facilities, together with all necessary, incidental or appurtenant properties, facilities, equipment and costs, and refunding a portion of the City's outstanding general obligation bonds; providing for the levy of general

ad valorem taxes to pay the principal of and interest on the Bonds; authorizing the execution of certain agreements and providing other details in connection therewith; ratifying action previously taken relating thereto; providing other matters relating thereto; and making other provisions relating thereto.

### G. Human Services -

BR10-0350 - Authorizes acceptance of \$86,004.57 from Lutheran Family Services of Colorado to the Department of Human Services to provide appropriate skills for unaccompanied minor refugees to enter adulthood and to achieve social self-sufficiency.

#### H. Parks and Recreation -

BR10-0351 - Approves an agreement with Street Kidz to administer programs for youth at Globeville Recreation Center.

BR10-0363 - Approval of Colorado Miners agreement to administer programs for youth at Johnson Recreation Center

BR10-0354 - Request to set-up a capital grant fund to accept and appropriate \$92,529.52 from the Colorado Department of Transportation for the construction of a new bison overlook in the Denver Mountain Parks Genesee Park.

BR10-0352 - A Contract amendment for American Civil Constructors

BR10-0362 - Request to file for the correction of the City Clerk's Filing No. on Ordinance No. 196, Council Bill No. 182, Series 2010

BR10-0349 - Approval of Summer Scholars contract amendment for a 5 year extension.

### I. Public Works -

RR10-0387 - granting a revocable permit, subject to certain terms and conditions, to Denver Bike Sharing, their successors and assigns, to encroach into the right-of-way with bicycle docking stations at 2 separate locations.
