This is a resolution request to approve the Collective Bargaining Agreement (CBA) between the City and County of Denver (City) and Fraternal Order of Police, Denver Sheriff Lodge 27 (FOP), regarding pay and benefits for the years 2024 and 2025.

The successor contract contains a number of amendments to the current CBA which expired 12/31/2023, including (1) setting the minimum overtime rate at 1.5X a deputy's regular rate of pay; (2) payment of a minimum of 1 hour of overtime for time spent attending firearms qualifications; (3) increasing the one-time weapons allowance from \$650 to \$1,000; (4) adding Juneteenth as a recognized holiday; (5) granting up to 4 weeks of paid parental leave for new parents (beginning 1/1/2025); and (6) a 3.0% salary increase effective 1/1/2024, a 4.0% salary increase effective 7/1/2024, a 2.0% salary increase effective 1/1/2025, and a 3.0% salary increase effective 7/1/2025.
