3. Meets at least three of ten criteria
4. LPC considers historic context





 - Lack of embellishment






 - Single family, multi-unit, retail, shopping centers, office buildings, schools, motels, and warehouses
- Catholic Archdiocese of Denver
 - Designed numerous churches & parish halls
 - Event Hall - prestressed double tee concrete
 - Early usage nationwide
 - Likely first in Denver
 - Makes it significant example of work





Police, firemen, postal employees and military personnel in uniform will join city, state and county officials, and just plain citizens in a march at 7 a.m. from Knights of Columbus Home, 1575 Grant St. to Mass at Immaculate Conception Cathedral. The Most Rev. James V. Casey, bishop of Lincoln, Neb., will speak. After Mass, parade will continue to Denver Hilton Hotel for breakfast.

Knights Schedule Ground Breaking

Knights of Columbus Denver Council 539 will break ground for its new home at E. 16th Ave. and Grant St. in ceremonies at noon Friday.

The first dirt will be shoveled by newly elected Grand Knight William T. Dressler and John Hinterritter, president of the Knights of Columbus Assn. They will use a gold-colored shovel.

State and city government officials will attend. A luncheon address will be given by John J. Sullivan, Denver investment

banker, who was grand knight of the council from 1926-28.

The proposed \$100,000 building will be the third home for the council in its 62-year history.

Martin J. Carmody, Grand Rapids, Mich., national head of the Knights of Columbus, will be in Denver, Sunday, Nov. 18, for the dedication of the new Knights of Columbus hall. The day's service also will include welcoming Bishop J. Henry Tihen, who returned last week from a trip abroad and commemorating the twenty-eighth anniversary of the institution of the Denver council.

Following a blessing at 4 o'clock in the afternoon a reception will be held for the bishop. Members of the charter class of the Denver council, district deputies from the state, grand knights from state councils and visiting delegations are expected for the banquet at 7 o'clock when Bishop Tihen and Mr. Carmody will be guests of honor.

**K of C Parade 1982
Set Saturday**

The Denver Knights of Columbus will be celebrating its 100th anniversary with the second annual Columbus Day Parade Saturday, October 9 to leave from the Civic Center at 10 a.m.

In addition to the El Jebel Shrine and representation from approximately eight Knights of Columbus assemblies including the Knights' Fourth Degree members, the parade will feature musical bands, floats, Miss Colorado, various veterans groups, representation from the military as well as participation by vintage car groups. Dear Members of the Landmark Preservation Commission,

Historic Denver supports the local landmark designation of 1555 N. Grant Street, encompassing the full parcel—including the 1928 Buell Hall, the 1963 Milan Hall, and the adjoining L-shaped parking lot—as a unified historic resource that reflects multiple layers of Denver's architectural, social, and urban development history.

Designed by noted Denver architect Temple Buell, the 1928 French Renaissance Revival hall adapted and reused portions of the site's earlier carriage complex, blending original stone and brick fabric with refined new construction. The result is a rare composition that visibly expresses the site's evolution across decades. The 1963 addition by architect John F. Milan contributes to this story through its Mid-Century Modern form and technical innovation. Its use of locally produced prestressed concrete double-tee members—employed not only in the roof and floor but as the building's exterior walls—represents an early and significant example of this Colorado-born construction method.

Socially, the property holds deep associations with the Knights of Columbus Denver Council 539, one of the city's oldest and most active service organizations. During World War II, the Council transformed the site into a United Service Organizations (U.S.O.) center that served an estimated half million service members in just three years. This extraordinary level of wartime activity contributed to the deterioration of the former Fletcher Mansion and ultimately informed the site's redevelopment. The nomination also highlights the organization's broader history in Denver, including its response to anti-Catholic sentiment through civic engagement and visible patriotism—important social themes that remain embodied in this property.

- LPC considers the historic context

Based on ordinance designation criteria and on the findings of the Landmark Preservation Commission (LPC) that the application meets the criteria for designation of a structure, staff recommends the application is forwarded to full council.
