Approval of this contract will allow for the installation and permanent acceptance of a new sculpture into the City's art collection. "Connections", by artist Robert Pietruszewski, is a 30'-foot high contemporary kinetic sculpture (see Figure A) of stainless steel and titanium. The proposed sculpture was specifically commissioned by Frank Bingham and Landis Martin and intended for installation at the southwest corner of Skyline Park (Dist 8). The sculpture is being donated in honor of his family members Becca, Macie and Garrison Bingham. There will be no cost to the City to fabricate or install the sculpture, and because of its materials, it poses no maintenance burden. The proposal has been reviewed and approved by Kevin Patterson, Manager of Parks & Recreation, the Public Art Committee and Commission on Cultural Affairs. It will be a gift to this urban park and a distinctive vertical element in a park that is not likely to have any additional funds for public art in the near future.
