11 **Special Revenue Fund to the Energy Efficiency Assistance fund.**

14 **WHEREAS**, the Energy Efficiency Assistance Fund is authorized to receive approximately
15 \$2 million per year in revenue derived from a portion of the Public Service Company of Colorado
16 (Xcel Energy) right-of-way franchise fee to provide energy efficiency programs for individuals and
17 non-profit agencies;
