5 **A BILL**

6 **For an ordinance assessing the annual costs of the continuing care, operation,**
7 **repair, maintenance and replacement of the South Broadway Streetscape**
8 **(Arizona Avenue to Iowa Avenue) Local Maintenance District upon the real**
9 **property, exclusive of improvements thereon, benefited.**

11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

12 **Section 1.** Upon consideration of the recommendation of the Manager of Public Works that
13 an ordinance be enacted for the purpose of assessing the annual costs of the continuing care,
14 operation, repair, maintenance and replacement of the South Broadway Streetscape (Arizona
15 Avenue to Iowa Avenue) Local Maintenance District (“South Broadway Streetscape (Arizona Avenue
16 to Iowa Avenue)”), for the upcoming year, upon the real property, exclusive of improvements thereon,
17 benefited, the Council finds, as follows:

18 (a) A local maintenance district providing for the continuing care, operation, repair,
19 maintenance and replacement of the South Broadway Streetscape (Arizona Avenue to Iowa
20 Avenue), was created by Ordinance No. 38, Series of 2008;

21 (b) The annual cost of the continuing care, operation, repair, maintenance and
22 replacement of the South Broadway Streetscape (Arizona Avenue to Iowa Avenue) is \$47,200.00,
23 which amount the Manager of Public Works has the authority to expend for the purposes stated
24 herein;

25 (c) The Manager of Public Works has complied with all provisions of law relating to the
26 publishing of notice to the owners of real properties to be assessed and to all persons interested
27 generally, and the Council sitting as a Board of Equalization has heard and determined all written
28 complaints and objections, if any, filed with the Manager of Public Works;

29 (d) The real property within the South Broadway Streetscape (Arizona Avenue to Iowa
30 Avenue) will be benefited in an amount equal to or in excess of the amount to be assessed against
31 said property because of the continuing care, operation, repair, maintenance and replacement of
32 said South Broadway Streetscape (Arizona Avenue to Iowa Avenue).

33 **Section 2.** The annual cost of the continuing care, operation, repair, maintenance and
34 replacement of the South Broadway Streetscape (Arizona Avenue to Iowa Avenue) to be assessed
35 against the real properties, exclusive of improvements thereon, benefited are hereby approved.

1 **Section 3.** The annual costs of the continuing care, operation, repair, maintenance and
 2 replacement of the South Broadway Streetscape (Arizona Avenue to Iowa Avenue) in the amount of
 3 \$47,200.00 are hereby assessed against the real properties, exclusive of improvements thereon,
 4 within said local maintenance district as follows:

5 NOTE: Where a series of lots is followed by "inclusive", the amount appearing after the series shall
 6 be the total for all lots in the series. Where a series of lots is not followed by "inclusive", the amount
 7 appearing after such series shall be the assessment for each lot in the series.

40 **Section 4.** The assessments made pursuant hereto shall be a lien in the several amounts
41 assessed against each lot or tract of land set forth in Section 3 herein, and such lien shall have the
42 priority of the lien for local public improvement districts.

43 **Section 5.** Without demand, said assessments as set forth in Section 3 herein, shall be due
44 and payable on the first day of January of the year next following the year in which this assessing
45 ordinance became effective, and said assessments shall become delinquent if not paid by the last
46 day of February of the year next following the year in which this assessing ordinance became
47 effective. A failure to pay said assessments as hereinabove set forth shall become a lien on the

1 property subject to the assessment, and such lien may be sold by the City as provided by the Charter
2 and ordinances of the City and County of Denver.

3 **Section 6.** Any unspent revenue and revenue generated through investment shall be
4 retained and credited to the South Broadway Streetscape (Arizona Avenue to Iowa Avenue) Local
5 Maintenance District for future long term or program maintenance of the District.
