TITLE: This request is to dedicate parcels of land as Public Right of Way known as Front View Crescent and the alley at the eastern corner of River Drive.

SUMMARY: Request for a Resolution for laying out, opening and establishing certain real property as part of the system of thoroughfares of the municipality; at Front View Crescent alley at the eastern corner of River Drive. These parcels of land are being dedicated to the City and County of Denver for Public Right-of-Way, as part of the development project Element 47.

These parcels of land were deeded to the City and County of Denver by a special Warranty Deed recorded in the Office of the Denver County clerk and Recorder on November 30, 2011, under Reception Number 2011135164.

It is requested that the above subject items be placed on the Mayor-Council Agenda for the next available date.

Therefore, you are requested to initiate Council action to dedicate two parcels of land for Public Right-of-Way purposes located at River Drive and at Front View Crescent. The land is described as follows.

- (1) **Exhibit A, Front View Crescent**, from the southeast corner of lot 46, block 3, of River Front in the Town Of Highlands, westerly approximately 432.84 feet, then northwesterly approximately 12.87 feet, both along the south boundary of block 3 of River Front in the Town of Highlands, then easterly 444.76 feet, then southerly approximately 4.10 feet to the point of beginning, all in River Front in the Town of Highlands, the land in the following described area:

- (2) **Exhibit B, River Drive**, from the northwest corner of lot 1, block 2, River Front in the Town Of Highlands, easterly approximately 10 feet along the north boundary of lot 1, then southerly approximately 241.04 feet to the south right of way line of River Drive, then westerly 29.42 feet, then northeasterly 23.91 feet to a point at the center line of River Drive, then northerly approximately 221.39 feet to the point of beginning, all in River Front in the Town of Highlands, the land in the following described area;
