**A BILL**

**For an ordinance repealing Section 15-16 of the Revised Municipal Code as obsolete and repealing and reenacting Section 15-17 of the Revised Municipal Code to update the precinct plan for city council districts.**

**WHEREAS**, pursuant to Sections 8.1.2 (E) and (F) the Clerk and Recorder is vested with exclusive authority for the conduct of elections and performs other duties as may be required by the charter or by ordinance; and

**WHEREAS**, under Section 15-4 of the Revised Municipal Code, municipal elections are governed by the Colorado Uniform Election Code, articles 1 through 13 of title 1, Colo. Rev. Stat., as amended, except as otherwise provided in chapter 15 of the Revised Municipal Code or the Charter; and

**WHEREAS**, the Elections Division, under the direction of the Clerk and in in accordance with state law, including without limitation Sections 1-5-102 and 1-5-104, Colo. Rev. Stat., establishes and makes changes to precincts for municipal elections; and

**WHEREAS**, the Elections Division has determined the precinct plan contained in Section 15-16 is obsolete and certain updates to the precinct plan set forth at Section 15-17 of the Revised Municipal Code are necessary for elections conducted on or after January 1, 2018; and

**WHEREAS**, the revised precinct plan is contained on a city-wide Council District map, prepared by the Elections Division of the Clerk and Recorder’s Office, establishing the precincts for the City and County of Denver without changes to existing council district boundaries, as approved by Ordinance No. 242, Series of 2012, for all eleven (11) individual city council districts.

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**SECTION 1.** Section 15-16 of the D.R.M.C. is hereby repealed.

**SECTION 2.** Section 15-17 of the D.R.M.C. is hereby repealed and reenacted as follows:

1 **Sec. 15-17. Boundaries and Precinct Plan for the council districts for municipal conducted**  
2 **on or after January 1, 2018.**

3 For all municipal general and special elections conducted on or after January 1, 2018, the  
4 precincts for the eleven (11) council districts shall be as described below. The districts shall consist  
5 of whole election precincts. The boundaries of the council districts, as approved by the City Council  
6 in Ordinance No. 242, Series of 2012, and the boundaries of the precincts described below are  
7 depicted on a council district and precinct map on file in the office of the Clerk and Recorder at City  
8 Clerk Filing No. 2018-0016.
