9 For an ordinance approving and providing for the execution of a proposed  
10 Intergovernmental Agreement between the City and County of Denver and the  
11 Colorado Department of Transportation concerning the "Colorado Boulevard  
12 Transit Signal Priority" project and the funding therefor.

14 WHEREAS, the City and County of Denver has given due consideration to said proposed  
15 Intergovernmental Agreement;

16 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY  
17 OF DENVER:

18 Section 1. The proposed Intergovernmental Agreement between the Colorado Department  
19 of Transportation and the City and County of Denver, a copy of which is duly filed with the City  
20 Clerk, Filing No. 10-570, be and hereby is approved in all respects.

21 Section 2. The Mayor or his lawful successor and other proper officials of the City and  
22 County of Denver, in its behalf, are hereby authorized and directed to execute said  
23 Intergovernmental Agreement and the Clerk and Recorder of the City and County of Denver is  
24 hereby authorized and directed to attest and impress the official seal of the City and County of  
25 Denver on the Intergovernmental Agreement.

26 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and  
27 other officials of the City are hereby authorized and directed to do all things required to be done  
28 in order to obtain payments under the Intergovernmental Agreement, including, but not limited  
29 to, filing requests for payments, contracting with persons and organizations in order to carry out  
30 the provisions of the Intergovernmental Agreement amendment, filing reports and keeping  
31 records relating to fiscal and evaluation matters, and forwarding other materials to the Colorado  
32 Department of Transportation.

33 Section 4. The payments made by the Colorado Department of Transportation to the City  
34 pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of  
35 the City and credited to Special Fund No. 38000, which is set forth and described in  
36 Section 20-18 of the Revised Municipal Code of the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said
