The Mayor, his successor in office, or his duly authorized representatives, and other officials of the City are hereby authorized and directed to do all things required to be done in order to obtain payments under the Intergovernmental Agreement, including, but not limited to, filing requests for payments, contracting with persons and organizations in order to carry out the provisions of the Intergovernmental Agreement amendment, filing reports and keeping records relating to fiscal and evaluation matters, and forwarding other materials to the Colorado Department of Transportation.

Section 4. The payments made by the Colorado Department of Transportation to the City pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.
