Ordinance 1255, series of 2017 modified the fund name from the "Planned Fleet Replacement Fund" to the "Planned Fleet Fund" and updated the scope to include new and replacement vehicles and heavy equipment. This bill request seeks to amend ordinance 184, series of 1992, as amended by ordinance 1255, series of 2017, to expand the scope to include costs that improve fleet equipment availability, including but not limited to purchasing parts, outsourcing for repairs, and labor for maintenance.
