A BILL

For an ordinance amending Chapter 18 of the Revised Municipal Code to establish the 2020 salary and fringe benefits of the Sheriff, Deputy Sheriff Division Chiefs and Deputy Sheriff Majors.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That effective January 1, 2020, Chapter 18, Article IV, Section 18-101 of the Revised Municipal Code is hereby amended to read as follows:

Sec. 18-101. Deputy sheriff major, deputy sheriff division chief, and sheriff pay plans.

~~(a)~~ ~~Effective January 1, 2018, the annual salary for deputy sheriff majors, deputy sheriff division chiefs and the sheriff shall be as follows:~~

~~Deputy sheriff major: \$141,666.00~~

~~Deputy sheriff division chief promoted or appointed before January 31, 2016:
\$164,951.00~~

~~Deputy sheriff division chief appointed on or after February 1, 2016: \$175,666.00~~

~~Sheriff: \$188,812.00~~

~~(b)~~ **(a)** Effective January 1, ~~2019~~ **2020**, the annual salary for deputy sheriff majors, deputy sheriff division chiefs and the sheriff shall be as follows:

Deputy sheriff major: ~~\$145,916.00~~ **\$151,023.00**

Deputy sheriff division chief promoted or appointed before January 31, 2016:
~~\$169,900.00~~ **\$175,847.00**

Deputy sheriff division chief appointed on or after February 1, 2016: ~~\$180,936.00~~
\$187,269.00

Sheriff: ~~\$194,476.00~~ **\$201,283.00**

Section 2. That effective January 1, 2020, Chapter 18, Article IV, Section 18-110 of the Revised Municipal Code is hereby amended to read as follows:

Sec. 18-110. Uniform maintenance.

An annual allowance shall be paid to deputy sheriff majors, deputy sheriff division chiefs, and the undersheriff for the maintenance of uniforms in the amount of six hundred **fifty** dollars

1 ~~(\$600)~~ **(\$650)**. This payment shall be made at the end of each calendar year. Upon separation
2 other than for cause, this payment shall be prorated for the number of months served during the
3 calendar year.
