A RESOLUTION

Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the United States Department of Transportation Federal Railroad Administration concerning the “Central Denver/BNSF Railroad Crossing” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the City and County of Denver and the United States of America Department of Transportation Federal Railroad Administration, for the “Central Denver/BNSF Railroad Crossing” program, which is identified as Grant Number 69A36525421700RCECO, a copy of which is duly filed with the City Clerk, Filing No. 202581151, be and hereby is approved in all respects.

Section 2. The payments made by the United States Department of Transportation Federal Railroad Administration to the City pursuant to and under the Grant Agreements shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Department of Transportation and Infrastructure and Opportunity, is as follows:

Expenditures of said funds are authorized from contract execution through February 29, 2028. This award requires a City cash match of \$300,000 that will be funded by the Traffic Signal Infrastructure and Maintenance Program PZ037 appropriation.
