SUMMARY: The purpose of this resolution is to dedicate Tracts conveyed to The City and County of

Denver. Said Tracts were created by the subdivision: Lowry Filing No. 15

It is requested that the above subject item be placed on the Mayor-Council Agenda for the next available date.

These parcels of land were deeded to the City and County of Denver by a Special Warranty Deed recorded in the Office of the Denver County Clerk and Recorder on February 14, 2011, under Reception Number 2011016571 to facilitate the Lowry Filing No. 15 development, which is located between 8Ave. and 9th Ave., and between Trenton St. and Ulster St.

Therefore, you are requested to initiate Council action to dedicate the following as:

(1) <u>8th Pl.</u>, from the northeast corner of lot 7, block 2, Lowry Filing No. 15, northwesterly to the southeast corner of lot 6, block 1, westerly along the north boundary of 8th Pl., to the southwest corner of lot 11, block 1, then southwesterly to the northwest corner of lot 1, block 2, then southeasterly to the northeast corner of lot 7, block 2, the land in the following described area:
