A BILL

6 **For an ordinance approving and accepting the Far Southwest Area Plan, which**
7 **Plan shall become a part of Comprehensive Plan 2040 for the City and County**
8 **of Denver pursuant to the provisions of Section 12-61 of the Denver Revised**
9 **Municipal Code.**

10 **WHEREAS**, pursuant to the provisions of Section 12-61 of the Denver Revised Municipal
11 Code (“DRMC”), and by Ordinance No. 302, Series of 2019, there has been approved a
12 Comprehensive Plan for the City and County of Denver (“Comprehensive Plan 2040”); and

13 **WHEREAS**, Section 12-61 of the DRMC provides for the supplementation of Comprehensive
14 Plan 2040; and

15 **WHEREAS**, by Ordinance No. 20190818, Series of 2019, the City accepted the Loretto
16 Heights Small Plan as a supplement to the City’s comprehensive plan; and

17 **WHEREAS**, the City wishes to repeal and replace the Loretto Heights Small Area Plan with
18 an updated comprehensive plan supplement, entitled Far Southwest Area Plan, for the orderly
19 growth and harmonious development of the City and County of Denver; and

20 **WHEREAS**, pursuant to the provisions of Section 12-61 DRMC, the City wishes to
21 supplement Comprehensive Plan 2040 by approving and accepting the Far Southwest Area Plan;
22 and

23 **WHEREAS**, members of the City Council, duly authorized by the president of council have
24 monitored the process whereby said Far Southwest Area Plan has been formulated; and

25 **WHEREAS**, the Far Southwest Area Plan has been approved by the Denver Planning Board;
26 and

27 **WHEREAS**, the Manager of Community Planning and Development has transmitted the Far
28 Southwest Area Plan to the Mayor and Council for acceptance as a supplement to Comprehensive
29 Plan 2040; and

30 **NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
31 **DENVER;**

32 **Section 1.** That the proposed Far Southwest Area Plan, consisting of a document of the
33 same name filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on the 19th
34 day of November as City Clerk Filing No. 20250200, is hereby adopted and accepted as a

1 supplement to Comprehensive Plan 2040, pursuant to Section 12-61(d) of the DRMC.

2 **Section 2.** That the Far Southwest Area Plan replaces and supersedes the Loretto Heights
3 Small Area Plan.

4 **Section 3.** That this adoption and acceptance of the Far Southwest Area Plan, and of any
5 amendment thereto, in conjunction with Comprehensive Plan 2040, is intended to establish the
6 official guide for officials of the City and County of Denver and private citizens when making decisions
7 affecting the future of land use and transportation in and for the City and County of Denver, as
8 defined in said plan; provided however, that such approval shall not preempt the decision making
9 powers vested by law or administrative directive in the Mayor, the Council or any other official of the
10 City and County of Denver with respect to, but not limited to: a zoning map amendment, a zoning
11 language amendment, a dedication or vacation of a street, alley or other public way, a designation
12 of a park, the issuance of a revocable permit, a conveyance or acquisition of real property by the
13 City and County of Denver, or an appropriation for or construction of a capital improvement; and
14 provided, further that it is expressly understood that judgment must be exercised in the application
15 of Far Southwest Area Plan in the decision making processes of the Mayor, Council and other
16 officials of the City and County of Denver.
