5 **Laying out, opening and establishing as part of the City street system parcels of**
6 **land as: 1) Public Alley, bounded by West Florida Avenue, South Acoma Street,**
7 **and West Iowa Avenue; 2) West Florida Avenue, located at the intersection of**
8 **West Florida Avenue and South Acoma Street; and 3) South Acoma Street,**
9 **located at the intersection of South Acoma Street and West Florida Avenue.**

10 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of
11 the City and County of Denver has found and determined that the public use, convenience and
12 necessity require the laying out, opening and establishing as a public alley and public streets
13 designated as part of the system of thoroughfares of the municipality those portions of real property
14 hereinafter more particularly described, and, subject to approval by resolution has laid out, opened
15 and established the same as a public alley and public streets;
