The State of Colorado's Department of Human Services contracts with Denver's Department of Environmental Health's Public Health Inspection Division's Child Care Facility Inspection Program to provide services related to childcare facility inspections. Services include original licensure, renewals, complaints, and investigations for family child care homes, school-age programs, child care centers, day treatments and children's residence camps located in Denver County.

This amendment extends the contract term for an additional year through 06/30/2017 and adds an additional \$640,641 to the revenue amount for total of \$1,207,003.
