Amendment No. 15-07.06a This amendment is to add \$800,000 in UDFCD funding for the Final Design, Right-of-Way Acquisition and Construction of Drainage and Flood Control Improvements along Sanderson Gulch, Lipan Street to the South Platte River. These funds will be used primarily for design and construction. The project will construct flood control improvements along Sanderson Gulch to ultimately remove 94 properties from the floodplain. By reducing the risk of flooding from 10-, 25-, 50-, and 100-year events, and theoretically reducing the size of the floodplain in Denver this project protects the lives of citizens who live, work, and frequent this area, as well as infrastructure (roads and railway bridges) and a portion of the local economy (local businesses).
