The last regularly scheduled Council meeting within the 30-day review period is on 5-20-13. The Committee approved filing this bill at its meeting on 4-17-13.

CB13-0224 A bill for an ordinance approving a proposed Standard Food and Beverage Concession Space Agreement between the City and County of Denver and CI/EL-ROI, JV concerning a concession at Denver International Airport.

Approves a sixth amendment to the Colorado Coalition for the Homeless (CCH) contract to add \$144,000 and one year through December 31, 2013 for Assertive Community Treatment (ACT) services to mentally-ill and homeless persons in the Court to Community Court Intervention Program (CE-70053 (6)). The last regularly scheduled Council meeting within the 30-day review period is on 5-20-13. The Committee approved filing this bill by consent on 4-18-13.

CB13-0254 A bill for an ordinance approving the Seventh Amendatory Agreement between the City and County of Denver and the Mental Health Center of Denver to provide Assertive Community Treatment (ACT) as part of the Court to Community Intervention Program.

Approves a seventh amendment to the Mental Health Center of Denver contract to add \$90,000 and one year through December 31, 2013, to provide Assertive Community Treatment (ACT) services to mentally ill and homeless persons in the Court to Community Court Intervention Program (CE-71064 (7).
