Scope of Board/Commission: The Denver Community Corrections Board oversees the acceptance and rejection criteria for all offenders considered for placement in the Denver Community Corrections Residential program.

The Board is made up of representatives across the criminal justice spectrum.

• 10 represent criminal justice and human services departments, One represents Victim Services, Two have experience or expertise in criminal justice, Six are citizens of the City and County of Denver, One is a locally elected official, One is a representative of Denver Public Schools

Appointment Process: The Board has 21 members who are appointed by the Mayor and confirmed by City Council for 4 year terms.

Mayor Mike Johnston has approved the appointment of Andrew Zavaras.

Andy has served as the Deputy Compact Administrator of the Interstate Commission for Adult Offender Supervision (ICAOS) and in 2022, he was appointed by Governor Polis as

Commissioner of ICAOS for the State of Colorado. In addition to his ability to connect and foster relationships with other state agencies, Andy is passionate about intentional leadership and working through barriers that affect performance and culture.
