SECOND AMENDMENT TO OFFICE SPACE LEASE

WHEREAS, the parties desire to amend the Existing Lease to increase the amount of Office Space from 279.6 sq. ft. to 1,622.5 sq. ft. to better support Tenant's operations;

NOW THEREFORE, for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

- 1. Effective as of the date this Second Amendment is executed, the Existing Lease is hereby amended by deleting *Exhibit A* (279.6 sq. ft.) attached thereto entirely and replacing it with the *Exhibit A*, (including Exhibits A, A-1, A-2; and A-3) totaling (1,622.5 sq. ft.) appended hereto, which is incorporated by reference as if fully set forth herein, with a corresponding adjustment to the rates, fee, and charges for this Office Space.
- 2. Except as modified by this Second Amendment, all of the terms and conditions of this Lease shall remain in full force and effect as if fully set forth herein.
- 3. This Second Amendment is expressly subject to and shall not be or become effective or binding on the City until approved by City Council, if required by the City's Charter, and fully executed by all signatories of the City and County of Denver. This Second Amendment may be executed in two or more counterparts, each of which will be deemed an original signature page to this Amendment and it may be signed electronically by either party in the manner specified by the City.


