

## FOURTH AMENDATORY AGREEMENT

**THIS FOURTH AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (“City”), and the **COLORADO DEPARTMENT OF CORRECTIONS** with a principal office located at 2862 South Circle Drive, Colorado Springs, Colorado 80906 (“DOC”), collectively referred to as the “Parties.”

### WITNESSETH:

**WHEREAS**, the Parties entered into an agreement dated March 16, 2010, and amended the agreement on June 24, 2011, October 15, 2012, and September 25, 2013, to provide out-patient hemo-dialysis through the DOC and related services to incarcerated patients held within the custody of the Denver Sheriff’s Department (“Agreement”); and

**WHEREAS**, the Parties desire to amend the Agreement to extend the term, change DOC’s point of contact and address, and to update other contract language.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

**1.** Section 1.1 of the Agreement entitled “Term and Termination” is hereby amended to read as follows:

“1.1. This Agreement shall become effective on **August 1, 2009** upon the approval and signature by the authorized representatives of the agencies hereto and shall continue until **July 31, 2016**, or such time as either agency gives thirty (30) days advance written notice of termination to the other agency.”

**2.** Section 3.1 of the Agreement entitled “**Billing and Payment**” is hereby amended to read as follows:

“3.1. Denver agrees to reimburse DOC at a rate of Three Hundred Thirty-Five Dollars and Zero Cents (\$335.00) per patient treatment.”

**3.** Section 4.6.1 of the Agreement is hereby amended to read as follows:

“4.6.1. For the DOC:  
Rena Jordan, Director, Clinical and Correctional Services  
2862 S. Circle Drive  
Colorado Springs, CO 80906”

**4.** This Fourth Amendatory Agreement may be executed in counterparts, each of which shall be deemed to be an original, and all of which, taken together, shall constitute one and

the same instrument.

**5.** Except as herein amended, the Agreement is affirmed and ratified in each and every particular.
