Scope of work:

To support and engage eligible Colorado Works/TANF participants to develop strategies that address individual and family needs, DHS will work jointly with GW to provide the following:

- In-depth assessment, family coaching, and work support programs associated with the implementation and operation of the TANF Program for households classified as needing Tier I or II services.
- Tier I services include but are not limited to: focusing on motivational interviewing, career assessments, resume building, mock interviews, and other job placements including subsidized employment.
- Tier II services include but are not limited to: intensive case management, life and work skills classes, career exploration, Adult Basic Education (ABE), GED/HSE attainment, and ongoing post-job placement support.

GW will serve up to 600 participants each month for service through the Colorado Works/TANF program. Services are available both in person and virtually based on the current safety recommendations and participant preferences.
