10 **WHEREAS**, ordinance 651, series 2015 appropriated and transferred \$2 million from the
11 General Fund to the Capital Improvement and Capital Maintenance Fund for the acquisition of
12 5135 Race Court; and

13 **WHEREAS**, the General Fund is being reimbursed by the National Western Center Bond
14 proceeds as intended;
