7 For an ordinance amending the annual salaries of certain appointed charter officers

8
9 WHEREAS, Colorado Constitution Art. XX, Sec. 2 requires that the compensation of the
10 officers of the City and County of Denver be expressed as a stated salary fixed by ordinance within
11 limits fixed by the Charter; and

12 WHEREAS, in accordance with § 9.2.3 of the Charter the Career Service Board has
13 determined a pay range for each appointed charter officer listed in § 9.2.1 (B) of the Charter; and

14 WHEREAS, the annual salaries set forth herein do not exceed the maximum salaries set forth
15 in the pay ranges determined by the Career Service Board, as required by § 9.2.3 of the Charter.

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
18 **DENVER:**

20 **Section 1.** That Chapter 18, Article III, Division 2, Sections 18-91 of the Revised Municipal Code
21 is hereby amended by adding the language underlined and deleting the language stricken to read as
22 follows:

24 **Section 18-91. Salaries.**

26 The career service board having determined limits of the salaries of appointed charter officers in
27 accordance with the limitations of section 9.2.3 of the Charter, the council hereby fixes the annual
28 salaries as follows:
