## **Executive Summary**

Purpose:	This request is to approve \$1,050,000 in CDBG funds structured as a fully amortizing 15- year loan for \$800,000 and a 7-year performance loan for \$250,000. The loan will finance the acquisition by La Clinica Tepeyac of property located at 4725 High Street for behavioral health and health promotion services and administrative use.

Description:	Clinica Tepeyac is a 501(c)3 non-profit corporation and Federally Qualified Health Center with a mission to provide culturally competent health care and preventative health services for the medically underserved. Clinica Tepeyac was formed in 1994 through a community-driven process and today provides health care services to over 4,500 low- income patients each year in the Globeville and Elyria Swansea neighborhoods. Clinica Tepeyac has occupied the subject property as a tenant since 2013. The space is used to provide behavioral health and health promotion services as well as administrative functions, and complements Clinica Tepeyac's medical clinic space at 5075 Lincoln Street. The purpose of this loan is to enable Clinica Tepeyac to purchase this property to support the organization's financial sustainability and ensure that Clinica Tepeyac can continue to provide health services to the Globeville and Elyria Swansea community. The financing request is for \$1,050,000 of CDBG funds, split into an \$800,000 loan with a term of 15 years and fully amortizing payments at an interest rate of 1.5%; and a \$250,000 7-year performance loan for which payments will be deferred and forgiven on the condition that Clinica Tepeyac continues to use the space to provide the same services. In addition to fulfilling the CDBG National Objective of serving an area in which 51% or more of residents are of low and moderate income, the vast majority of Clinica Tepeyac's patients that Clinica Tepeyac serves are low income. In 2014, 97% of patients served earned less than 200% of the federal poverty level and 70-80% were uninsured.
