**TITLE:** Request for a Resolution for laying out, opening and establishing certain real properties as part of the system of thoroughfares of the municipality and dedicating as Right-of-Way, certain Tracts created by Lowry Filing No.14

**SUMMARY:** The purpose of this resolution is to dedicate Tracts conveyed to The City and County of Denver. Said Tracts were created by the subdivision: Lowry Filing No. 14

It is requested that the above subject item be placed on the Mayor-Council Agenda for the next available date.

These parcels of land were deeded to the City and County of Denver by a Special Warranty Deed recorded in the Office of the Denver County Clerk and Recorder on February 14, 2011, under Reception Number 2011016572 to facilitate the Lowry Filing No. 14 development, which is located on Proposed Lowry Blvd & Proposed Alton Way.

Therefore, you are requested to initiate Council action to dedicate the following as:

- (1) **Lowry Blvd.**, from the center line of Dayton St, westerly to the westerly line of Proposed Alton Way extended north, the land in the described area:  
**Tract A, Lowry Filing No. 14, City and County of Denver, State of Colorado;**
- (2) **Lowry Blvd.**, from the westerly line of Tract A (Proposed Lowry Blvd.), westerly and southwesterly to the westerly line of Yosemite St., the land in the following described area:  
**Tract B, Lowry Filing No. 14, City and County of Denver, State of Colorado;**
- (3) **Alton Way.**, from the south line of Tract A (Proposed Lowry Blvd.), southerly and southwesterly to a point 245.88 feet north from the center lines intersection of 5<sup>th</sup> Ave. and Dayton Way, Lowry filing 23, the land in the following described area:  
**Tract C, Lowry Filing No. 14, City and County of Denver, State of Colorado;**

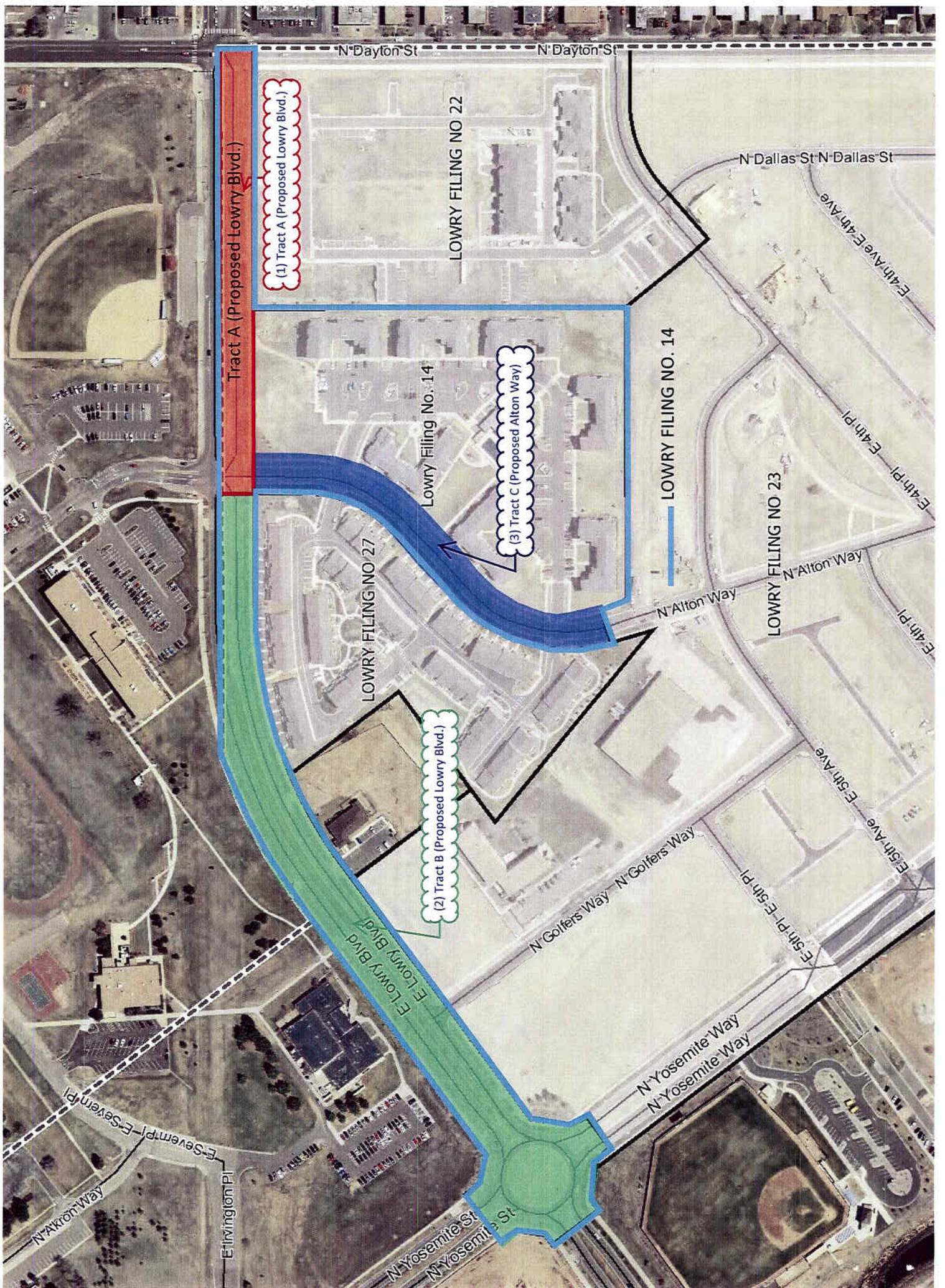
