5 **A BILL**

6 **For an ordinance amending portions of Chapter 28, Article III, Article V and**  
7 **Article VII to extend sunset dates.**

8 **WHEREAS**, the Denver Economic Development Office, Division of Small Business Opportunity  
9 (“DSBO”), is responsible for the functions, powers and duties assigned to it under the Denver Revised  
10 Municipal Code, including development and enforcement of the Minority-Owned Business Enterprise  
11 (“MBE”), Woman-Owned Business Enterprise (“WBE”) and Small Business Enterprise (“SBE”)  
12 programs as related to construction under Article III, goods and services under Article V, and the SBE  
13 program under Article VII (collectively “MWBE and SBE Programs”); and

14 **WHEREAS**, in order to allow DSBO and affected agencies to revise the ordinance and  
15 Programs, as well as finalize the DSBO rules and regulations; DSBO desires a limited extension of the  
16 pertinent dates of expiration of Articles III, V and VII and the MWBE and SBE Programs.

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
18 **DENVER:**

19 **Section 1.** Section 28-83(b) of the Denver Revised Municipal Code is amended by deleting  
20 the language stricken and adding the language underlined to read as follows:

21 “(b) This division 3 shall be repealed effective **May 1** ~~July 1~~ ~~December 31, 2020~~ ~~2019~~.”

22 **Section 2.** Section 28-158(b) of the Denver Revised Municipal Code is amended by  
23 deleting the language stricken and adding the language underlined to read as follows:

24 “(b) This article V shall be repealed effective **May 1** ~~July 1~~ ~~December 31, 2020~~ ~~2019~~.”

25 **Section 3.** Section 28-234(b) of the Denver Revised Municipal Code is amended by  
26 deleting the language stricken and adding the language underlined to read as follows:

27 “(b) This article VII shall be repealed effective **May 1** ~~July 1~~ ~~December 31, 2020~~ ~~2019~~.”
