**A RESOLUTION**

City and County of Denver, et al.*, which was filed in the United States District Court for the District of Colorado, Case Nos. 1:20-cv-1878-RBJ-KLM & 1:20-cv-1922-RBJ-MEH (consol.).

**BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** That the Council of the City and County of Denver hereby approves and authorizes the expenditure and payment from the 2023 appropriation account designated as “liability claims” (Accounting Number 11827 4511001), the sum of four million seven hundred twenty thousand dollars (\$4,720,000.00) made payable to Kurtzman Carson Consultants d/b/a KCC, in full payment and satisfaction of all claims related to the arrest class portion of the civil action captioned *Elisabeth Epps, et al. v. City and County of Denver, et al.*, which was filed in the United States District Court for the District of Colorado, Case Nos. 1:20-cv-1878-RBJ-KLM & 1:20-cv-1922-RBJ-MEH (consol.).

Payment is to be made upon the execution and delivery of such release or releases as is or are satisfactory to the attorney for the City and County of Denver and approval of settlement by the United States District Court for the District of Colorado.
