A BILL

For an ordinance to close various Special Revenue Funds and authorizing cash transfers to the General Fund, the General Government Special Revenue Fund Series, and the Economic Opportunity Special Revenue Fund Series.

WHEREAS, the City has several inactive Special Revenue Funds that are no longer being used; and

WHEREAS, said Special Revenue Funds have positive or negative cash balances that must be zeroed out before closing; and

WHEREAS, remaining cash in the Special Revenue Funds with positive cash balances will be transferred to the General Fund and then transferred to the Special Revenue Funds with negative balances for said close out;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. There is hereby authorized the transfer of cash from the Special Revenue Funds and Trust Funds to the General Fund and General Government Special Revenue Fund Series in the amounts indicated in the following tabulation:


