- 5. Describe the proposed ordinance, including what the proposed ordinance is intended to accomplish, who's involved
  - a. Scope of Work

This ordinance request is to secure a contract between the City and County of Denver and Design Workshop for the Decatur-Federal Station Area Plan and General Development Plan process which also include a Colfax/Federal Interchange Study. The City and County of Denver, in partnership with the Denver Housing Authority is sponsoring a strategic transit-oriented development planning process for the Decatur-Federal light rail station area due to open in 2013. This contract secures the services of a multidisciplinary consultant ream with a wide range of expertise including but not limited to urban design, site and infrastructure/transportation planning, low- and mixed-income housing development, and market analysis/scenario development. Included within the project area is the DHA Sun Valley Homes community as well as large holding property owners including the Invesco Field/Stadium District and Xcel Energy.

This effort is funded by several partners. Grants received by Community Planning and Development from the federal agencies of Housing and Urban Development (HUD) and Department of Transportation (DOT) will fund \$634,571. The Denver Housing Authority (DHA) is funding \$25,000 of this planning process through an Intergovernmental Agreement (IGA) between the City and County of DHA.

West Denver. Planning area occurs within ½ mile of the Decatur-Federal light rail station on the RTD West line. Approximate boundaries include Lowell Blvd, 17th Avenue, I-25 and 8th Avenue. Neighborhoods include Sun Valley, Villa Park and West Colfax.
