A BILL

For an ordinance amending Ordinance No. 740, Series of 2014, concerning creating the “Child Care Facility Inspection” Special Revenue Fund and changing it from a cash basis fund to an appropriated fund and making an appropriation from said fund.

THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That Section 3 of Ordinance No. 740 Series of 2014, is hereby amended to read as follows:

“Section 3. There is hereby appropriated to the appropriation account hereinafter designated the amounts of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
