Approves a no-cost extension of the contract with Dan Steinberg Presents, LLC to 12-31-15 for the Denver Arts & Venues Promoter Commission Program (THTRS-201313563). The last regularly scheduled Council meeting within the 30-day review period is on 2-2-15. The Committee approved filing this bill by consent on 12-31-14.

CB14-1129 A bill for an ordinance approving a proposed First Amendment to Concession Agreement between the City and County of Denver and Aramark Sports and Entertainment Services, LLC, to provide food and beverage concession at City venues.

Changes the contract year for a concession agreement with Aramark Sports and Entertainment Services, LLC for food and beverage services in City venues and clarifies how minimum guaranteed payments are made (THTRS-201205498). The last regularly scheduled Council meeting within the 30-day review period is on 2-2-15. The Committee approved filing this bill by consent on 12-31-14.

CB14-1131 A bill for an Ordinance approving a Third Amendment to Contract Services Agreement with Smith Environmental, Inc., d/b/a Smith Environmental and Engineering for the provision of on-call ecological services.

Adds \$200,000 to the contract with The Smith Environmental, Inc. (for a new total of \$650,000) and extends it to 2-8-16 for on-call ecological services for Parks and Recreation (OC201103346).
