6 **For an ordinance making an appropriation in the Grant and Other Money**
7 **Projects Fund Series to make a cash transfer to the Capital Improvements and**
8 **Capital Maintenance Fund Series.**

10 **WHEREAS**, in 2012, the East Corridor IGA First Amendment between the City and County
11 of Denver (City) and the Regional Transportation District (RTD) was executed to provide funding
12 for the Eagle Project, a public-private partnership to extend commuter rail services in the Denver
13 Metro area; and

14 **WHEREAS**, per the terms of the agreement, the City provided RTD an advance of sales
15 and use taxes paid on materials during construction of the Eagle Project to RTD and, following the
16 completion of the project, RTD is required to repay the cumulative total of the advance from any
17 amount of remaining contingency; and

18 **WHEREAS**, the project is reaching its close, and the City invoiced RTD and has received
19 the final reimbursement amount which has been deposited in the original project fund, the East
20 Corridor Fund Accounting No. 38349, per the City's fiscal policies; and

21 **WHEREAS**, Ordinance No. 1446, Series of 2022, Section 18, appropriates budget in the
22 Public Works Improvement Projects Fund Accounting No. 31050; and

23 **WHEREAS**, the City needs to transfer the cash from the East Corridor Fund to the Public
24 Works Improvement Projects Fund to align the cash with the approved appropriation;

26 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
27 **OF DENVER:**

29 **Section 1.** From the Grant and Other Money Projects Fund, Accounting No. 38000, out of
30 monies not otherwise appropriated and in addition to the amounts heretofore appropriated by
31 Ordinance No. 1446, Series of 2022, and any supplemental appropriations or rescissions there is
32 hereby appropriated to the appropriation account hereinafter designated the amounts of money

1 following each such designation, to be expended for the purposes and upon the authorizations in
2 said Ordinance set forth:
