**A RESOLUTION**

**Approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the Colorado Office of the Governor concerning the "Governor's Emergency Education Relief (GEER II)" program and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**Section 1.** The proposed Grant Agreement, between the Colorado Office of the Governor and the City and County of Denver, which is identified as Grant Number JHZYLXQAKY33, a copy of which is duly filed with the City Clerk, Filing No. 202474195, be and hereby is approved in all respects.

**Section 2.** The payments made by the Colorado Office of the Governor to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said Program, to be expended by the Director of the Office of Children's Affairs:
