5 **A BILL**

6 **For an ordinance making a supplemental appropriation in the Capital**  
7 **Improvement Fund.**

8  
9 **WHEREAS**, in non-reassessment years, the City can restore credited property tax mills up  
10 to the 2A allowable growth cap; and

11 **WHEREAS**, in 2020, mills are being restored to generate additional revenue in 2021 across  
12 four funds, including the General Fund, Human Services, Affordable Housing and Capital  
13 Improvement Fund (CIF); and

14 **WHEREAS**, the associated revenue for all funds except CIF were appropriated in the 2021  
15 Budget Book; and

16 **WHEREAS**, the Capital Planning and Programming Division of the Department of Finance  
17 wishes to appropriate the \$2,279,317 in revenue attributed to the CIF portion of the restored  
18 credited property tax mills to support the commitment to additional street paving supported by  
19 ballot measure 2A, which voters approved in 2012, and was previously supported by a General  
20 Fund transfer; and

21 **WHEREAS**, this appropriation will restore the funding for that commitment;

23 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
24 **OF DENVER:**

26 **Section 1.** From the Capital Improvement Fund, Accounting No. 31000, not otherwise  
27 appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1216, Series of  
28 2020, and any supplemental appropriations or rescissions, there is hereby appropriated to the  
29 appropriation accounts hereinafter designated the amount of money following such designation, to  
30 be expended for the purposes and upon the authorizations in said Ordinance set forth:
