5. General description or background of proposed request.

This amendment extends the term through 12/31/25.

These funds are being provided to support construction-related Incumbent Worker Training for 170 individuals, providing workers with the skills necessary to retain employment and see advancement within the organization. The Incumbent Worker Training program also provides funding for businesses to avert layoffs, increase the company's competitiveness, and see an increase in return on investment into their employees. Denver Workforce Development is providing the Community College of Denver with \$781,962.00 in Denver Construction Careers Program Incumbent Worker Training funds.

As of 6/30/2025, CCD has enrolled 26 participants and anticipate a significant increase in enrollments with the start of the Fall semester.
