Approves an intergovernmental agreement with DHA that outlines the partnership between DHA and City and County of Denver to support the first phase of development of a park along the South Platte River in the Sun Valley neighborhood that will span from W. 9th Avenue to W. 11th Avenue. DHA currently owns the land. Following construction, all park lands will be transferred to the City. The cost of construction of the park is \$8.5 million, with CCD providing \$3 million and DHA providing the remaining balance of \$5.5 million.

In partnership with DHA, project aims to construct Phase 1 of a ~4.5 acre riverfront park which includes trail connections to the South Platte River Trail and the Weir Gulch Trail. Amenities to include meandering trails through a tranquil garden space, play grounds for all ages, a splash pad with interactive water features, great lawn area, large and open multi-purpose central pavilion, community gardens, food truck and special event connections, ethno-botanical gardens representative of the community cultures, and a dog park.
