## **Business, Workforce & Sustainability**

- RR10- Approves a Resolution to set a public hearing for January 3, 2011 relating to approval of an amendment to the Downtown Denver Urban Renewal Plan for the Historic Colorado National Bank Building Project.
- BR10- Approves a one-year extension through December 31, 2011 to the Key Lime Air Corporation contract at Denver International Airport for airport use and cargo facilities.
- BR10- Approves an extension through December 31, 2011 to the United Parcel Service CO contract at Denver International Airport for airfield and cargo facilities.
- BR10- Approves a Non-Disturbance, Attornment, and Concession Agreement to the DIA Baked Goods, Inc. dba Ben & Jerry's contract to allow a leasehold in the event of default by Skyport Development Company to retain its rights and obligations under the sublease.
- BR10- Approves a one-year term extension through December 31, 2011 to the Shuttle America Corporation contract for airport use and facilities at Denver International Airport.
- RR10- Approves the following Mayoral reappointment of Yolanda Ortega to the 1018 Denver Commission on Cultural Affairs and the following Mayoral appointments of Claudia Jordan, Rick Tallman and Nancy Walsh for terms effective immediately and expiring August 31, 2013.

## **Government Affairs & Finance**

BR10- Approves a Master Purchase Order in the amount of \$3.6 million 1006 between the City and Global Mounting Solutions, Inc. to provide ruggedized laptops and related hardware.

## **Health, Safety, Education & Services**

- BR10- Accepts \$400,000 in state funding for the Colorado Prevention 1012 Partnership for Success grant for substance abuse prevention activities for Latino youth.
- BR10- Renew the Call Center contract and add \$454,512 to the budget for Affiliated Computer Services, Inc. for calendar year 2011 to provide the Child Support Enforcement Division with an in-house call center (CE91065(2)).
- BR10- Add \$211,680 and extend the contract with Denver Municipal 1014 Defenders, PC from January 1, 2011 to December 31, 2011 for legal services to indigent defendants charged with traffic and municipal ordinance violations.
- RR10- Approve the following Mayoral reappointments of Diego Hung and R. 1019 Mauricio Palacio to the Denver Latino Commission for terms effective immediately and expiring January 1, 2013.
- RR10- Approves the Mayoral reappointments of Khulan Dashpuntsag, Peggy 1020 Lore and Pam Sweetser to the Denver Asian Pacific Advisory Commission for terms effective immediately and expiring on October 22, 2012.
- BR10- Approves a \$500,000 Community Development Block Grant loan to Denver Health and Hospital Authority for its new Montbello Health Clinic in Council District 11.
