Business Development

- RR15-0629 Approves a contract with Jewish Family Service of Colorado, doing business as SHALOM Denver for Program Year 2015-16, in the amount of \$650,000, for the purpose of assisting in fulfilling Temporary Assistance for Needy Families (TANF) work participation requirements that lead to unsubsidized employment services for TANF recipients (OEDEV- 201523737-00).
- RR15-0634 Approves a lease agreement with Rocky Mountain Motion Corporation doing business as The Global Business Solution Providers in the amount of \$4,691 through 5-31-16 for office space at Denver International Airport to provide the administration of employee drug and alcohol testing for their airline partners (201523193).
- RR15-0635 Authorizes the Office of Economic Development (OED) to grant a sub-award to the Jefferson County America Job Center in the amount of \$735,581 to provide services under the Ready-to-Work grant agreement from the U.S. Department of Labor (201520647).

- RR15-0638 Approves a five-year, \$10.5 million purchase order with Toter, LLC for trash, recycling and compost carts for the citywide cart conversion program (0578A0115).
- RR15-0623 A resolution laying out, opening and establishing as part of the City street system a parcel of land as Magnolia Street at its intersection with East Colfax Avenue.
- RR15-0643 Approves the \$992,811 purchase of five replacement Peterbilt 220 cab and chassis from Rush Peterbilt Truck Center (PWOPS-0000012150).
- RR15-0648 A resolution laying out, opening and establishing as part of the City street system parcels of land as 33rd Avenue, 34th Avenue, 34th Place, 35th Avenue, 35th Place, 36th Avenue, 37th Avenue, Alton Street, Alton Court, Beeler Street, Beeler Court, and Boston Street, in Stapleton Filing No. 19.
- RR15-0650 Dedicates land as West 52nd Avenue at the intersection of West 52nd Avenue and Federal Boulevard in Council District 1.
- BR15-0652 Approves a \$286,585 purchase of five F-550 Cab and Chassis vehicles from Stone Motors, Inc. for graffiti abatement.
